For the official record, though, your officers include: Ken Zimmerman, President; Michael Kushnaryov, Vice President; Marleen Strachota, Secretary, with Dennis Defenbaugh, Chris Zillig and Natalie Zimmerman as Members of the Board. Dr. Hauser was invited to serve as an advisor and ex-officio member. Also for the record, we must draft a constitution, bylaws, and all that sort of thing but this, too, will be kept as simple as possible. You will be kept informed as these momentous steps are taken.

OUR INTENT AND PURPOSE, for the benefit of those who could not attend the first meeting, is to act as a social entity, nurturing our valued friendships, and to serve, in whatever ways we can, the needs and growth of the McBride programs as we seek to aid those who still suffer. For those of us in the Milwaukee area, this could involve visiting patients, conducting or sitting-in on "rap sessions" at the treatment center on a regular basis, picking up or dropping off out-of-town patients at the airport, serving as temporary sponsors during treatment and early after-care, informal or supportive counseling when deemed appropriate and other such "helping hand" activities. And there's always the need for spreading the word and promoting our "alma mater." Similar or additional duties will undoubtedly crop up from time to time and, especially for you out-of-town alums, we're looking for suggestions. You are no less important when it comes to our mutual reliance upon each other for ongoing strength and support, and the bolstering of these ties while they are still fresh is vital. Written and telephone contacts can be helpful, and a membership roster access policy is being developed. Please keep in touch. No one is under

obligation, of course, but it is hoped that the spirit of the Twelfth Step will be a factor in sustaining this worthwhile camaraderie and fellowship.

But nothing comes for nothing, we all know, and even the simplest of organizations, such as ours, must meet some basic expenses -- supplies, printing and postage, for example. We were thinking of something like \$5. ("and up") per member to help defray those costs. Down the road, however, we are looking at a more ambitious posture, with a true "foundation" role. Certainly most of us have much to be thankful for as a result of our McBride experience. When the occasion for charitable giving arises, what better conduit for our generosity than this association. Your Board is studying possibilities along this line and is most anxious to structure something in keeping with your wishes. Please feel free to offer comments or suggestions.
